MR. POTTER AND PARTY RETURN FROM 3,200-MILE TOUR.
Albert L. Potter and party returned Saturday from

The party included Mr. Potter, his son, Reuben P., his two daughters Ella and Eva and Miss Pounch. Most of the driving was done by his daughters and son.

Mr. Potter's automobile is a Thomas motor car, made in Buffalo, N. Y., which he bought last spring. It has a 24 H. P. engine. The route was 1,400 miles to St. Louis, about 1,500 returning. The balance of the 3,200 miles was made up in side trips.

HIGH SPEED AUTOS RACE AT WAVERLEY.

THRONG OF 5,000 SAW FIRST MEET OF NEW JERSEY AUTO-MOBILE AND MOTOR CLUB.

Races Were Fast and Exciting.
Ten Mile Race a Feature.

The car which carried off the principal honors in vesterday's meet was the Thomas Flyer, owned by H. S. Houpt. winner of the 10-mile race, the feature event of the day. This machine, which is of 40-horse power, outclassed and outdistanced everything on the track and finished first in the 10-mile race by a mile and a half, defeating the fastest cars in the State. The race was for a cup, free for all cars, regular catalogue equipment, costing up to \$6,500. As the car rounded the track for the third mile it lapped the Decauville, and at five miles it had gained a lap on all the machines. The leading vehicle fairly flew over the ground, and from then on it was plainly a runaway race. Passing the 9-mile mark it had once more ridden a circle around the other starters. The Thomas machine shot over the finish line two and a half laps ahead of its competitors, a remarkable performance on a half mile track.


